## School Service 2: Speech Sound Disorders

---

### Course Description

Pediatric speech sound disorders (SSD) is a broad term describing difficulties related to the motor, phonological or perceptual components of speech. SSDs impact individuals' intelligibility and can range from mild articulation disorders to more severe disorders such as childhood apraxia of speech. Speech language pathologists (SLPs) play an important role in differentiating communication differences and disorders during the assessment process, and providing appropriate interventions for students with speech sound disorders.

This course, presented by leading experts in speech-language pathology and allied professions, describes evidence-based assessment and intervention strategies of pediatric speech sound disorders. It equips SLPs with strategies and resources to enhance their delivery of these services to school-age children. Specific topics related to articulation, phonology, childhood apraxia of speech, AAC, cultural-linguistic diversity, and strategies for working with multilingual students are covered.

Content consists of SpeechPathology.com courses, which are available in various formats, including recorded (video) webinars, audio-only (podcast), and text. Each student will select relevant individual courses from SpeechPathology.com to total the required hours for the number of credits they wish to earn (1-4).

**Reflection Report**
